AMENDMENTS

THE Lions of Single District 10 (SD-10) adopted the Standard District Constitution and By-Laws as their Constitution (Rapid River, 2007). The document is available on the website of Lions International www.lionsinternational.org or SD-10 website www.district10lions.org and not distributed in document form. Accordingly, the document provisions cannot be amended physically (in the normal fashion of replacing or adding words to a written document of our own).

Amendments to the Constitution and By-Laws require a permanent and stable record, the Constitution and By-Laws Committee has determined that a separate document will serve as an amendments section. The SD-10 website will display all Amendments to the Constitution and By-Laws as separate documents for downloading and copying.

DEFINITIONS SECTION

- "District" This term, wherever it appears in this document (Constitution, By-Laws or Policy Manual) refers to the official name of our District, which is "Single District 10."
- "Constitution or By-Laws" For informational purposes, a Constitution generally includes basic provisions (Name, Officers, Membership, Meetings, basic Administration and rules to Amend, etc. By-Laws offer much more detail. Amendments require a two-thirds vote plus one to pass.
- "Resolutions" Resolutions do not amend the Constitution or the By-Laws. They can be statements of praise that honor individuals or groups or they can be statements of intent to do something temporarily (institute a practice or create a position) that might otherwise require an amendment. They can be used for this purpose if the body wishes to try something, temporarily, without formalizing the action. Resolutions require fifty percent plus one to pass.
