# 88th ANNUAL CONVENTION SINGLE DISTRICT 10 - LIONS OF MICHIGAN MARQUETTE, MICHIGAN April 23-25, 2010



#### **MIX & MEET**

April 23, 2010 - 6:30 p.m. Holiday Inn, Marquette, Michigan

#### **GENERAL SESSION**

April 24, 2010 - 9:00 a.m. Holiday Inn, Marquette, Michigan

**CALL TO ORDER** - The meeting was called to order by District Governor Don Wojakowski. Following the Pledge of Allegiance and invocation, dignitaries and guests were introduced.

#### **CREDENTIALS REPORT** – PDG Larry Klaus

The Credentials Committee reported that 160 people were registered. There were 81 delegates and 19 Past District Governors in attendance.

#### **RULES COMMITTEE REPORT** – PDG Sara Doubledee

- 1. **Order of Business:** Except as herein otherwise provided, the "Order of Business" shall be in the order given in the Business Session Agenda, a copy of which has been furnished each certified delegate and alternate.
- 2. **Deviation from the "Order of Business":** Deviation from the "Order of Business" as adopted by the convention shall occur only when authorized by proper motion approved by a majority of the delegates duly assembled.
- 3. **First "Order of Business":** The first "Order of Business" shall be the report of the Credentials Committee. No other business shall be transacted until the Credentials Committee shall have certified the number of delegates and alternates registered at the convention.
- 4. **Second "Order of Business":** The second "Order of Business" shall be the report of the Rules Committee. No other business shall be transacted until the Rules have been adopted.
- 5. **Parliamentary Procedure**: Except where otherwise herein provided, the "Newly Revised Edition of Robert's Rules of Order" shall govern matters of Parliamentary Procedure.
- 6. **Quorum:** A quorum for any duly scheduled meeting shall consist one more than half of the registered delegates certified to the Convention by the Credentials Committee and present at such meetings.
- 7. **Resolutions:** All proposed resolutions, except amendments to the Constitution and By-Laws, shall be presented to the Convention by the Chair of the Constitution and By-Laws under the conditions prescribed by the Constitution and By-Laws Committee.

#### 8. Amendments to the Constitution and By-Laws:

- A. **Amendments:** Amendments to the Constitution and By-Laws shall be presented to the Convention by the Chair of the Constitution and By-Laws under the conditions prescribed by the Constitution and By-Laws Committee.
- B. **Discussion:** Except as authorized by the Chair, discussion shall to limited to one principal speaker for and one principal speaker against, and three additional speakers each, pro and con. All discussion on any one amendment shall be limited to fourteen (14) minutes.
- C. **Voting:** Any vote pertaining to amendments to the Constitution and By-Laws, or resolutions requiring a vote, shall be by show of hands, except where otherwise required by the Constitution and By-Laws of District 10 and Lions International.

#### 9. Limitations on Speakers:

- D. **Subjects Before the Convention:** Each speaker discussing any matter, including proposed amendments or resolutions requiring a vote, shall be limited to three (3) minutes. An additional three (3) minutes shall be granted by the Chair without objection from the delegates.
- E. **Presentations:** Presentations shall limited to the time allowed by the presiding officer.
- 10. **Duties of the Sergeants-At-Arms:** The Sergeants-At-Arms are authorized to enforce the rules herein set forth.
- 11. **Call for Nominations:** The Call for Nominations shall be made three times before a motion to close nominations is in order.
- 12. **Suspension of the Rules:** Suspension of the Rules may be made by a two-thirds majority vote of the delegates assembled.

MOTION - Doubledee, Whippen, to adopt the Rules. Motion carried.

#### APPROVAL OF THE AGENDA

MOTION - Nicklas, Doubledee, to approve the proposed agenda. Motion carried.

#### FINANCIAL REPORT - Bruce LaBelle, SD 10 Treasurer

The Lions of Michigan Single District 10 checking account began the 2009-10 fiscal year with a balance of \$23,911.00 on July 1, 2009. The total income for the fiscal year was \$25,776.59 with disbursements totaling \$18,776.32, leaving a balance of \$30,911.27 as of April 23, 2010.

There are outstanding receipts totaling \$306.00 from three Lions Clubs that have not paid their 2009-10 2<sup>nd</sup> half dues. The delinquent Lions Clubs are Chippewa, Kinross and Trenary. The clubs have been mailed multiple invoices and have been contact by the Governor and other members of the Cabinet. There is also one Lions Club that owes money to Lions International that is more than 90-days past due, Chippewa.

The Hearing and Speech Restricted Account began the fiscal year 2009-10 with a balance of \$1,243.48; an additional \$1,450.00 was received from 18 Lions Clubs, and \$.45 in interest, leaving a balance of \$2,693.93 as on April 23, 2010.

The Mints Distribution and Sales Restricted Account began the fiscal year with a balance of \$2,159.25. An additional \$1,071.07 has been added to the account this fiscal year, along with \$.91 in interest, leaving a current balance of \$3,231.23 as of February 5, 2010. These funds are received for warehousing and distribution of Lion Mints and 5% gross sales of the mints.

The six-month certificate of deposit was renewed on December 3, 2009 for another six months. The current interest rate is 0.30%, down from 0.70%, and is currently valued at \$10,478.86 on February 4. The interest in compounded monthly and the YTD interest is \$5.33. The CD matures on Jun3 3, 2010.

The audit of SD 10's financial books still needs to be completed for the 2008-09 year. The books were audited through April 8, 2009 by auditor Alfred LeMaire. The books are currently scheduled to audit in June 2010.

The membership dues for international, state and the district will remain the same for the 2010-2011 fiscal year. See attached dues structure for breakdown of dues. There are two exceptions to the full membership dues.

<u>Family Member Dues Rate</u>: A family membership allows relatives to volunteer together at a reduced dues rate. Family members must meet membership requirements, live in the same household and belong to the same club. The first member of the family shall pay the normal entrance fees and full international dues (as well as any applicable club, district or multiple district dues). Subsequent

family members, up to a limit of four more, who meet the qualifications shall be required to pay one-half of the normal international dues and be exempted of any entrance fees.

Student Member Dues Rate: Students receive a special student dues concession, paying only half dues (\$US \$19.50) and are exempt of any entrance fees. All students enrolled in an educational institution between the age of legal majority in the jurisdiction in which they reside and through the age of 30 are eligible.

SD 10 Lions membership currently stands at 1800 as of April 16, 2010, up 24 members for the year. Although some clubs have made great strides in increasing their membership, the majority of them are continuing to lose membership.

#### **COMMITTEE REPORTS -**

#### All State Band Report - Jenny Ware, PDG

Because of your financial support, the Lions of Michigan All State Band will be sending 50 band students and 5 band staff to the Lions International Convention in Sydney, Australia this summer! This will be the band's 33<sup>rd</sup> consecutive Lions International Convention Parade! No other band in the world is able to make this statement. It is all happening because of you and your club's support.

Of the 50 students, SD 10 is proud to have five members in the band—Lauren Belanger, Rachelle Leveille, and Bridget Schumann from Escanaba; and Ellyn Oswald and Collette Robinson from Bark River.

On behalf of the band staff and the students that participate in this wonderful band, thank you for all you do to allow this tradition in Michigan to continue!

Brian Shepard, CEO of the Lions of Michigan All State Band, will be stepping down after this year's tour after 10 years of dedicated service.

#### **Project Kid Sight Report** – Jenny Ware, PDG

Between July 1, 2009 and April 21, 2010, nine screenings were held; 253 pre-school aged children were screened; and one was referred for further testing. Donations to date total \$2,556.

Thank you to the clubs that have donated so generously to this very worthwhile project!

Our desire to "serve" over this last year continues to grow. A couple trainings were held with more Lions becoming certified screeners. The Lions of Manistique Lakes, Newberry, Sault Ste. Marie and Brimley have been additional driving forces this year. I would like to acknowledge Lion Bill MacLachlan, Lion Al LeMaire, and PDG Bob St. peter for helping set up trainings, assuring screeners were trained and that were held. Without your support, this project would not be such a great success.

Since SD 10 started Project Kid Sight, we have screened 1656 pre-school aged children and have recommended 41 of them for further testing by an eye doctor. Due to federal confidentiality laws, known as HIPPA, we are unable to receive the names of the children. Therefore, we are not aware of follow-up by the parents, nor the results of the referrals.

I look forward to continuing on as Project Kid Sight Chair for the next year. I also look forward to working with all of the energetic Lions that are trained and that want to be trained as we continue to help save sight in our most valuable resource, our children!

#### Bay Cliff Report - Kris and William Rowe

The Rapid River Lions Club raised \$6,000 for Bay Cliff at their Wild Game Feed. Special thanks to them for their support. The Shady Nook project has received \$152,274.50 to date.

Lions Day at Bay Cliff is scheduled on July 31, 2010. There will be tours with teen campers between 10:30 a.m. and 12:30 p.m. Lunch with the campers at 12:30 p.m. A short presentation will follow lunch. Members are encouraged to attend and show their support for this district project.

#### Hearing Committee Report - Bob St. Peter, PDG

The committee continues to work with Intermediate School Districts because they are able to reach more people, providing information on speech therapy and electronic devices that help people to hear better

SD 10 continues to work with Lions International and the Lions of Michigan Foundation on the hearing aid program which assists in providing these devices to low-income individuals.

#### Extension Committee Report – Harold Schermer, PDG

To date, 16 have signed up for a new all-female Lions Club in Gladstone. PDG Schermer has been working on the formation of this club for 1½ years.

<u>MOTION</u> – Schermer, Kelly, to approve \$300 for newspaper ads to help promote membership in this new club. Motion defeated.

It was suggested that PDG Schermer try running announcements on the local PSA channel.

#### Leadership Development Report – Jim Decremer, PDG

PDG Decremer provided officer training for five clubs this year. He will present two breakout sessions this afternoon—Club President and Officer Orientation at 1:30 p.m. and Club Secretary Orientation at 2:30 p.m.

#### **Scholarship Report** – Jim Decremer, PDG

Six \$500 scholarships were presented in 2009-10. Twenty-five clubs have donated \$1,720 to date, but additional support is needed to continue the program. Money for scholarships comes from the interest earned on the \$36,081.16 invested in CDs, plus club donations.

The 2010 scholarships went to: Sara Trekas, Bessemer; Katrina Anderson, Iron Mountain; Stephen Alsteens, Kingsford; Toni Wilson, Kingsford; Seven Abbott, Marquette; and Jayson Barrett, Negaunee.

I would like to thank my committee for their help in the selection of scholarship recipients: Lions Maryce Farrell, Alice Majestic, Charlie Lundmark, Willie LaMarche and Matt Reeves. I would like to thank all the clubs who donated to this worthy project.

#### Michigan Eye Bank Report – Larry Klaus, PDG

The Eye Bank is growing, both in the number of people we can serve, but also physically. We are finally ready to market the software we have been developing over the last several years to other eye banks. We are also working with some countries overseas to develop a market for any excess

tissue. Our new call center came online earlier this year. That job had been done by the lab workers, but now there are so many new regulations and inspections that we would have had to hire more technicians or start the call center with lower wage personnel.

We are now also regulated by the Food and Drug Administration as well as the EBAA. The June board meeting will be my last as a director. The last two years, I have been elected Board Secretary. We have been trying to find a replacement for my spot on the board for at least nine months. We asked at every Cabinet meeting and in the last two issues of the SD 10 Magazine, but before we found someone, we had missed the deadline for submitting applications. It will be voted on at the June Board Meeting if we still have a candidate. I would like to thank the district for allowing me to represent the UP on the Eye Bank Board for the past six years.

I would also like to thank all those Lions who worked in the Secretary of State offices for "Buddy Day" on April 7. A special thank you to the Gwinn Lions Club President Peggy Lindeman, Jill Jenner, Marlene Breit and Marlene's daughter, Katelyn Polishuk, for helping me at the Marquette SOS office. The Lions did a great job signing up people for the Michigan Donor Program.

#### Northwoods Air Lifeline Report - George Kelly, PDG

Our volunteer pilots have been extremely busy this past Lions year. This past month they had requests for 17 flights. They have had to cancel four due to weather or equipment problems. We have also worked with other similar organizations (Angel Flights, etc.) in our area.

We realize the demand put on clubs requesting financial support. With the increase in operating costs, an average flight from Sault Ste. Marie to Marshfield, round trip, is approximately \$200 per hour. Inspection of our aircraft costs in the vicinity of \$4,000-\$6,000, depending on what maintenance has to be done. Most of the clubs have been sending in donations, and with help from outside businesses and organizations, we have been able to keep up with expenses. We do not request donations from those we serve, but most of them request information and do send in appreciation amounts.

The all-weather hangar that was built with the financial support of LCIF has been a great help, especially with our winter operation. The aircraft are kept in the hangar and are available for missions or maintenance out of the weather.

I have had the pleasure to serve as Lions Chairperson and on the NWALL Board of Directors since the day it was formed. At that time, our founder, Bob Larson, went to the floor of the convention and asked the lions to help support the cost of the flights. It passed unanimously. This is an excellent PR program for our clubs and district.
