5. REVIEW OF PAST CABINET MEETING MINUTES - DISTRICT SECRETARY PEGGY

 - ii. Motion passed.

6. DISTRICT TREASURER REPORT - DISTRICT TREASURER MIKE SMOCK

- a. Financial Review
 - i. Pg 2- Note revenue dues waived \$115 waived for first year of charter members for the new Marquette club.
 - ii. 2nd half of the year dues waived for those that met the incentive- will show up in this line as well
 - iii. Pg 7 accounts receivable aging summary- clubs owing including Calumet which has desolved this fiscal year. We paid 2025-2026 dues in July to Lions of Michigan. There is \$40 left due the District from the former club. Can we write this off?
 - 1. Alerted LCI before 7/1/25, but didn't get the paperwork in on time. Thus accumulated the \$40.
 - 2. Gov. Colleen Maki requests permission to write it off. Per IPDG Scott Kwarciany, the club submitted all the paperwork and did everything legal.

- 3. IPDG Jenny Ware motions, seconded by PDG Jim Svinicki. Motion passed.
- iv. Newberry and Menominee still on the accounts receivable list.
 - 1. Gov. Colleen Maki has tried to reach out to Newberry on several occasions with no luck.
 - 2. PDG Jim Whalen no longer at Teaching Family Homes.
 - 3. Need to see what's going on with this club
- v. Pg9- Bank statement reconciliation. There are 2 checks from May that have not been processed from UP Lion's Serve Diabetes and UP Lions Serve Hunger. Checks were from funds raised at convention. Lion Keith Smith at UP Lions Serve passed these checks on to the appropriate chairman for each service project.
- vi. IPDG Scott Kwarciany motions to place financial reports on file, DG Colleen Maki seconds. Motion passes.
- b. Report on Clubs that qualified for 2nd District dues billing abatement
 - i. 25 Clubs successfully qualified.
 - 1. Submitted officers
 - 2. Paid dues on time
 - ii. Mike asks cabinet for approval to waive the dues for those 25 clubs.
 - 1. Discussion is there a chance another club could make the list?
 - a. No
 - 2. Secretary Peggy Lindeman makes the motion, Lion Judy Racette seconds.
 - a. Gov. Colleen Maki points out that two of the clubs of the leadership team with the exception of Bay de Noc (Bark River, Powers-Spaulding) did not qualify!
 - b. Motion passed.
- c. District Garden Grants current & pending
 - i. None pending
 - ii. Issued 1 to Gwinn for \$500
 - iii. In the last 1.5 years \$2123 to 5 clubs
 - iv. Munising, Trenary, Drummond Island, Powers-Spaulding and Gwinn
- d. Budget Amendments will work with Lion Mike Smock to cover the deficits we may have due to any additional requests for the garden grants. VDG did not go to USA Canada Forum we may reroute those funds if needed thru a budget amendment.
 - i. Treasurer Mike Smock notes we will be getting additional revenue not in the budget due to the clubs that did not meet the dues waiver.

- e. Treasurer Mike Smock we are in the filing season for state filing of annual reports and for IRS 990's. 7 clubs have never been incorporated. 6 of the corporation entities have been dissolved due to not sending in their annual reports. 4 clubs have had their tax exemption revoked for not filing 990's (Newberry, Carney Nadeau, Chocolay, Menominee.) Ishpeming got reinstated.
 - i. 990 due November 15th to IRS
 - ii. Incorporation shields the members of the club and allows clubs to hold raffles, etc.

7. OLD BUSINESS

- a. District Representative needed for Michigan Forum recommended they have previously attended the Forum
 - i. Josh Trader stepped up-first time D10 put a member on the planning committee. Still highly recommended this person have attended in the past.
 - 1. PID Jenny Ware understands the recommendations, but doesn't feel it's necessary. Service project, learning session, lunch and done.
 - a. Mostly needs to get the information out and participates in the service project.
 - b. IPDG Scott Kwarciany- it's helpful if you have attended. Just don't want our representative to have them feel like they are drowning.
 - c. We have ran this past Julie Myers- not necessary, but helpful.
 - d. 1VDG Gary Perala will consider this and if he does he will take Lion Josh Trader and 2VDG Chris LeBoeuf under his wing
 - i. This should just be the duty of the 1VDG- per Gary
- b. Sign off on Gwinn LCI Grant LION STEVE FINLEY
 - i. Final report by Steve Finley to be passed on to the LCI grant for Governor to sign off.
 - 1. Lion Steve Finley- with 1VDG Gary Perala's help did "let's seed UP"- shared UP friendly seeds distributed across the UP thru 42

lions clubs. We also sent seed packets to 3 clubs down state. 17,000 seeds in gardens growing food to share.

2. PID Jenny Ware makes motion to accept the report, sign off on it and sent the report to LCIF. Seconded by Secretary Peggy Lindeman. Motion passes.

Lion Steve Finley presented with an official LCI hunger pin.

8. NEW BUSINESS

- a. Multiple District 11 District 10 History PID JENNY WARE (See Document at end of meeting minutes.)
 - i. Back ground on the history between D10 and D11 (10 sub districts). In last several years there has been issues with D10 attending the council of governors. D10 went and looked at the history and the facts. Wrote report and sent it in for review by PID's, etc. Paper needs to go to VDG training for annual presentation and training of new VDG's. D10 started in 1919 as the first club in Michigan then Grand rapids 1 months later.
 - ii. Each has own governing bodies and constitutions.
 - iii. They have district, state and joint projects.
 - iv. MD11 council of governors makes decisions affecting D10- then with D10 present it becomes a has joint council of governors.
 - v. Issue is that MD11 language speaks to allowing D10 to have ex-ificio rep by Governor only. Giving this person the same rights.
 - 1. MD11 has the ability to change this.
 - vi. We pay dues to MD11 that pays our executive director and other employees and other funds.
 - vii. Our last increase to the state was 1999-2000.
 - viii. Will send out a copy of the report to everyone.
 - ix. What are the benefits of us unifying.
 - 1. We would pay more dues for what?
 - 2. Currently send about \$3400 per year-joint training sessions, pay Lion Wendy Burns to come to our convention and take minutes.
 - 3. LCI has never requested we merge.
 - 4. None of the districts downstate are compliant with membership requirements.
 - 5. GAT team members are now included in reporting to some meetings and cabinets. We need to be careful not to vote on items that do not include D10.

- 6. D10 leadership has been working hard to improve and keep our relationship open. This has been reflected in the number of Governors that come up and attend our convention.
- b. All State Band Raffle IPDG SCOTT KWARCIANY
 - i. Last year's raffle sold 100 tickets at \$100 took in \$10,000- paid out and received money back ending up with around \$7000. \$750 to each student.
 - ii. Bark River ran raffle last year because district did not have it in its bylaws to get a raffle- now district may apply for the license.
 - 1. Do we want to do this again? It's to Hong Kong.
 - 2. Sell more tickets for less? It's hard to sell \$100 tickets. Get families involved and start selling tickets earlier.
 - 3. Motion to do again by Secretary Peggy Lindeman, seconded by Lion Steve Finley.
 - 4. IPDG Scott Kwarciany could come up with a plan on how to do the raffle by the first zoom meeting next month.
 - 5. Motion passed.
 - 6. PID Jenny Ware will get with IPDG Scott Kwarciany to come up with the plan.
- c. District Committee Written Reports DG COLLEEN/DISTRICT SECRETARY PEGGY
 - i. Cabinet mtg report- 15 with no reports.
 - ii. Want permission from the cabinet to eliminate reports line items that we don't know what they are for or what needs to be reported.
 - iii. Lion's quest- Lion Judy Racette turned it down. And we don't have the program.
 - iv. Need to add Human trafficking report to cabinet meeting minutes.

9. GAT TEAM REPORTS

- a. GLT PDG Gretchen Preston Report submitted. Next roundtable Nov1 at wells clubhouse for south central area lions. Will be going to Houghton Hancock lions to give Leaderdog presentation to 4 different clubs. Newsletter is in danger as Gretchen writes 90% of the articles and still looking for webmaster to distribute.
- b. GST PDG Jim Svinicki 40-55 percent of clubs have been reporting.
- c. GMT/GET IPDG Scott
 - i. GMT=can see who is coming and going. -3 for year with calumet closing. Ended with +15 last year thanks to new club. We're stable.

- ii. GET- Work to go out into the district to invigorate new clubs or bring back clubs to towns that use to have clubs.
 - 1. Lost Calumet- would have been 100 years old.
 - 2. Potential new club in delta county area. Was an old folded club that are still together doing things- what does it take to get them back.
 - 3. Potential in the Garden area.
 - 4. West end needs help.
 - 5. PID Jenny Ware- Rapid River is struggling. Event coming up.

Single District 10 and Multiple District 11 History and Relationship

First club in the State of Michigan formed in Marquette October, 1919. District 10. Second club in the State formed two weeks later in Grand Rapids. District 11.

Single District 10 (SD10) has a District Governor who oversees the Cabinet. Their governing documents are the Single District Constitution and By-Laws through Lions International and their Policy Manual.

Multiple District 11 (MD11) has a Council Chairperson who oversees the Council of Governors comprised of the 10 Sub-District Governors in MD11. Their governing documents are the Multiple District Constitution and By-Laws through Lions International and their Policy Manual.

SD10 has District Projects that have gone through the proper process in the District and have been voted upon by delegates at the SD10 conventions. A District project can be approved at a Cabinet Meeting by a vote of the Cabinet.

MD11 Projects **pages 24-28 MD11 Constitution and By-Laws

MD11 has Multiple District Projects and each sub-district has District Projects.

These projects have been approved at the MD11 and sub-district levels via their Constitutions and By-Laws.

<u>State Projects</u> are projects that as stated in the MD11 C&B-Ls, are 501©3 entities and have gone through the approval process by both SD10 and MD11. The State Projects are:

- 1. All State Band
- 2. Eversight
- 3. Leader Dogs
- 4. Lions of Michigan Service Foundation

The State Committee is comprised of the 11 District Chairs. State Committee Chairperson is elected from the sitting committee.

<u>Joint Projects</u> are projects that have been mutually agreed upon by both SD10 and MD11 and have appointed representatives on the committee(s). The current Joint Projects are the Liaison Committee and the International Convention Committee.

<u>Council of Governors meetings:</u> MD11 holds regularly scheduled Council of Governors meetings. During these meetings items that may affect SD10 may be on the agenda. If this occurs, it is then called a Joint Meeting of the Council of Governors. The Vice District Governors are invited to attend.

MD11 C&B, page 29: ARTICLE XIV Joint Action with Single District 10

Section 1. The Council of Governors of Multiple District 11 is hereby authorized to enter into a joint policy agreement with the Governor of Single District 10, such agreement to be binding for any specified term, or until terminated by agreement or by provisions therein contained.

(This language speaks directly to the MD11 policy manual and having the authority for the council of MD11 to create the "ex-officio" position for the DG of SD10.)

Section 2. Such policy agreement may provide for joint sessions of the Council of Governors of both Multiple District 11 and Single District 10, jointly called by the Governor of Single District 10 and the MD11 Council Chairperson or as determined by joint action at a joint meeting of the Governors.

Items that jointly impact SD10/MD11: Executive Director Financial Reports/State Treasurer State Projects – listed above Joint Projects – listed above

Conventions:

SD10 has an annual District Convention.
MD11 has an annual Multiple District Convention.
Each Sub-District in MD11 has an annual District Convention.

MD11 Joint Action with SD10:

ARTICLE XIV, Joint Action with Single District 10, Page 29 MD11 Constitution and By-Laws MD11 Policy Manual, Page 7, CLARIFICATION OF TERMS, paragraph 2:

"In the spirit of cooperation and collegiality with our fellow Lions in Single District 10, which is comprised of the entire Upper Peninsula of Michigan; Single District 10's District Governor is considered an exofficio member of the Council of Governors of Multiple District 11 and is entitled to all rights and privileges due to the office. Likewise, all Single District 10 Vice Governors are invited to partake in the Leadership Training provided by the Multiple District 11 Global Leadership Team."

SD Dues paid to MD11, \$2.58 per Member

* \$0.40 to the Lions of Michigan International Convention Fund

This covers expenses of a gathering room and snacks/water at the Lions of Michigan hotel – this hotel is designated by LCI

**\$0.50 to the Liaison Fund

This is used for Lions seeking international positions – International Director, 3VP, 2VP, International President

***\$1.68 to State Office Administrative cost

Employee wages, expenses, supplies, building costs, etc.
